What is Venture Capital and are New Hampshire firms benefiting from Venture Capital?

Venture capital can be defined as equity funding provided to fast-growing entrepreneurial companies by professional investors. Funding can be in the form of a direct cash investment or by a private placement of securities.

New Hampshire companies have benefited from venture capital and the infusion of funds. The peak of venture capital investments on record was reached in 2000 with \$655.5 million worth of investments made in 56 businesses.

Computer-related companies received \$379.6 million worth of investments in 2000, with \$223.2 million in *Networking and Equipment* alone. Computer-related investments accounted for 57.9 percent of all investments that

year. After the peak of 2000, venture capital investments in New Hampshire experienced a steep decline. The drop in venture capital investments in New Hampshire followed the "dot.com" bust in combination with the recession of 2001.

Investments in 2001 only reached a total of \$214.4 million, down 67.3 percent from the peak in 2000. Investments in computer-related firms continued to predominate, though, claiming almost two-thirds of the smaller 2001 venture capital investment pie.

Software firms have long been a favorite of investors in New Hampshire, according to records provided by PricewaterhouseCoopers that began tracking venture capital investments

in 1995. Reports from 1995 through 2009 show that the *Software* industry in New Hampshire had received \$513.4 million, a total of 21.5 percent of the entire venture capital investment on record. The same data reveal that *Networking and Equipment* was the recipient with the next largest investment of \$462.2 million, a 19.4 percent share. However, *Networking and Equipment* received nearly half of its \$462.2 million during the computer boom of 2000. The recipient of the third largest amount of funding from venture capitalists is Industrial Energy with a fifteen-year total of \$342.6 million, or 14.4 percent.

The years that followed the recession of 2001 never regained the level of venture capital investment seen dur-



ing the “dot.com” boom of 2000. Since the decline from 2000 to 2001, venture capital investments in New Hampshire firms have averaged \$145.5 million annually.

A total of 12 venture capital investments were made in New Hampshire during 2009, worth a total value of \$37.5 million. Of the 12 investments made, four *Industrial Energy* firms received just over \$17 million, 45.4 percent of the total. For the second straight year, *Industrial Energy* firms have received the largest portion of venture capital funding


Investments in 2009 dropped well below the 2008 level and the annual average that followed the 2000 to 2001

decline. The total \$37.5 million investment was down 78.3 percent from the \$153 million in 2008.

Considering current economic conditions, it is not surprising to discover that venture capital investments in New Hampshire declined during 2009. The year-to-year decrease from 2008 may be a sign that investors were being cautious as a result of the economic crisis. And even though the annual amount of investments by venture capitalists was low in 2009, the final two quarters of 2009 finished strong with \$34.2 million, representing 91.2 percent of the year’s activity. This increase of investment activity late in 2009 could be a positive sign of what may be expected in 2010.




New Hampshire unemployment and labor force estimates are calculated using a regression model which depends on Current Population Survey (CPS) estimates. Labor Market Area estimates are calculated using the Bureau of Labor Statistics "Handbook Method" and then adjusted to the State levels.

Monthly Analysis of Current Employment Statistics (CES) Data

Seasonally Adjusted: Preliminary seasonally adjusted employment increased by 2,000 jobs from November to December. Professional and business services (supersector 60) contributed to this growth adding 2,100 jobs over-the-month. Within professional and business services, administrative and support and waste management and remediation services (sector 56) accounted for 1,700 jobs from November to December. Leisure and hospitality (supersector 70) and other services (supersector 80) gained 700 jobs and 300 jobs, respectively. Over-the-month, construction (supersector 20), manufacturing (supersector 30), trade, transportation, and utilities (supersector 40), and information (supersector 50) each remained unchanged.

From November to December government (supersector 90) lost 700 jobs. This loss was split between state government and local government, down 400 and 300 jobs, in turn. Financial activities (supersector 55) and private education and health services (supersector 65) each lost 200 jobs, over-the-month.

Over-the-year, preliminary seasonally adjusted employment decreased by 9,300 jobs. From December 2008 to December 2009 employers in manufacturing reduced their workforce by 6,600 jobs. Over eighty percent of this drop was in durable goods, down 5,700 jobs. Construction lost 2,200 jobs, over-the-year. Employment in

financial activities, leisure and hospitality, and government each declined by 1,500 jobs. Employment in trade, transportation, and utilities fell by 400 jobs from December 2008 to December 2009.

On a more positive note, employment in professional and business services increased by 3,200 jobs from December 2008 to December 2009. Over-the-year, other services and private education and health services each added 600 jobs and 500 jobs, in turn.

Seasonally Unadjusted: Preliminary not seasonally adjusted employment increased by 2,700 jobs, over-the-month. Professional and business services (supersector 60) gained 1,900 jobs from November to December. During this same time period, employers in trade, transportation, and utilities (supersector 40) added 1,500 jobs. Retail trade, part of trade, transportation, and utilities rose by 1,700 jobs, over-the-month. From November to December employment in leisure and hospitality (supersector 70) gained 1,400 jobs. Other services (supersector 80) grew by 200 jobs, over-the-month. Employers in manufacturing (supersector 30), information (supersector 50), financial activities (supersector 55), and mining and logging (supersector 10) each kept the same employment levels as they had in November.

Over-the-month, employment in government (supersector 90) lost 1,000

jobs. Employers in construction (supersector 20) reduced their workforce by 700 jobs from November to December. Private education and health services (supersector 65) decreased by 600 jobs, over-the-month.

From December 2008 to December 2009, preliminary not seasonally adjusted employment decreased by 9,500 jobs. Over-the-year, manufacturing lost 6,700 jobs. Employment in durable goods, a component of manufacturing, declined from December 2008 to December 2009, down 5,700 jobs. Over-the-year, employers in construction reduced their workforce by 2,200 jobs. Employment in government fell by 1,600 jobs from December 2008 to December 2009. This loss was predominately due to state government also down 1,600 jobs, over-the-year. Leisure and hospitality and financial activities each cut 1,500 jobs from December 2008 to December 2009.

On a positive note, professional and business services added 3,200 jobs, over-the-year. Three-fourths of this growth can be attributed to administrative and support and waste management and remediation services (sector 56), up 2,400 jobs. Education and health services and other services each added 600 jobs from December 2008 to December 2009.
