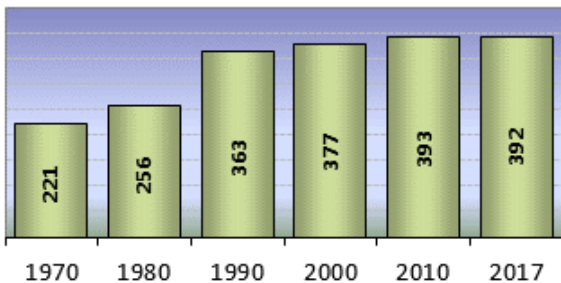
Incorporated: 1766

Origin: This town was chartered in 1766 to Clement March and other as Eaton. The name was in honor of Governor Theophilus Eaton of Connecticut (1590-1658). A prosperous London merchant, he was a generous contributor to the funds needed to settle Massachusetts in 1630. He later came to America and founded a colony at New Haven, Connecticut, along with John Davenport and David Yale, great-grandfather of the founder of Yale University, and served as Connecticut's governor for 19 years. Eaton includes the village of Snowville, named for the Snow family who started a sawmill there in 1825.

Villages and Place Names: Eaton Center, Snowville

Population, Year of the First Census Taken: 253 residents in 1790

Population Trends: Population change for Eaton totaled 241 over 57 years, from 151 in 1960 to 392 in 2017.



The largest decennial percent change was a 46 percent increase between 1960 and 1970; a 42 percent increase occurred between 1980 and 1990. The 2017 Census estimate for Eaton was 392 residents, which ranked 218th among New Hampshire's incorporated cities and towns.



Population Density and Land Area, 2017 (US Census Bureau): 16.1 persons per square mile of land area. Eaton contains 24.4 square miles of land area and 1.2 square miles of inland water area.
