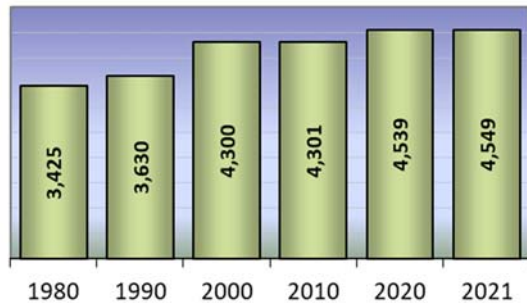
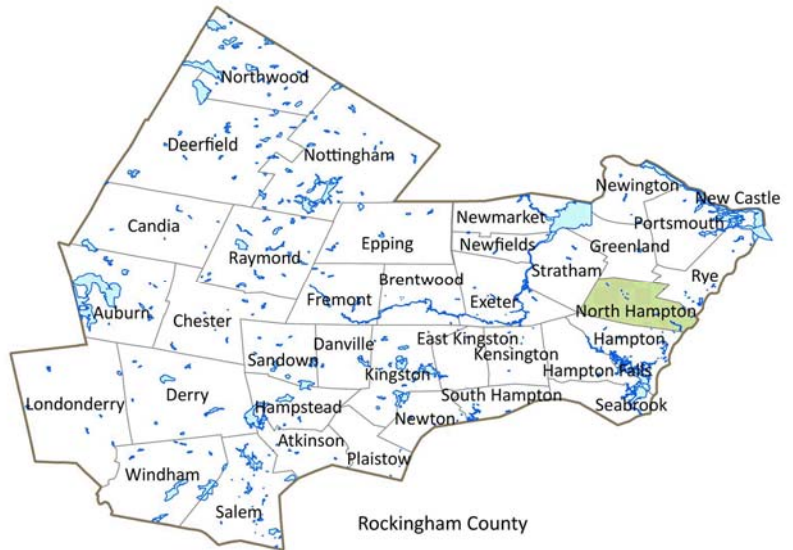

**Incorporated:** 1742

**Origin:** First settled in 1639, this town was a part of Hampton known as North Hill Parish. Residents began petitioning for a separate parish as early as 1719. North Hill Parish was set off from Hampton in 1738, with the responsibility of supporting a clergyman and schoolmaster of their own. Full township privileges were not granted until 1742, following the establishment of the New Hampshire-Massachusetts border. North Hampton was the birthplace of General Henry Dearborn, commander-in-chief of the American forces in the War of 1812, for whom Fort Dearborn (now Chicago) and Dearborn, Michigan, were named.

**Villages and Place Names:** Cemetery Corners, Fogg Corner, Little Boars Head, North Hampton Center, Bass Beach

**Population, Year of the First Census Taken:** 657 residents in 1790



**Population Trends:** Population change for North Hampton totaled 1,124 over 41 years, from 3,425 in 1980 to 4,549 in 2021. The largest decennial percent change was a 18 percent increase between 1990 and 2000. The 2021 Census estimate for North Hampton was 4,549 residents, which ranked 85th among New Hampshire's incorporated cities and towns.

**Population Density and Land Area, 2021 (US Census Bureau):** 326.6 persons per square mile of land area. North Hampton contains 13.9 square miles of land area and 0 square miles of inland water area.
