<u>Question 11.</u> Is the P-37 form supposed to be included in the bid package? This is not specified and in the past this was sent to us filled out to be signed after the contract was awarded.

NHES response: Section 8.C of RFP 2021-05 provides, "[t]he Agency will require the successful bidder to execute a Not to Exceed Contract using the Standard Terms and Conditions of the State of New Hampshire which is attached as Appendix A . . . The Agency may consider modifications of this form during negotiations. To the extent that a Proposer believes that exceptions to the standard form contract will be necessary for the proposer to enter into the Agreement, the Proposer should not those issues during the Proposer Inquiry Period."

Proposers are not required to submit the P-37 form with their proposal. A copy of the form is provided as some prospective bidders may raise exceptions to the terms. The deadline for Proposers to raise exceptions to the terms has not been and is not amended by this Addendum.

Question 12. On attachment D there is a line asking for the NH Employer ID#. Can you tell me where I would find this?

NHES response: The NH Employer ID# is the Proposer's UC account number with NHES.
