RESPONSES TO RFP# 2023-01, SECION 4B, PROPOSAL INQUIRIES. This Addendum #1 to RFP 2023-01 includes timely responses to proposer inquiries received by the required date of February 7, 2023, as follows:

1. What is the projected annual processing volume for debit/credit card payments?

NHES Response: NHES has no historical information available from which to make an estimate. Currently, without a debit/credit card payment option, NHES collected approximately \$3.9M in debt in 2022.

2. What is the projected number of transactions annually?

NHES Response: NHES has no historical information available from which to make an estimate.

3. How is the Department of Employment Security looking to accept credit cards? What is your ideal payment landscape? Examples – eCommerce payments, Keyed- In via web-based product (Virtual Terminal), email invoicing, recurring payments, Face to Face.

NHES Response: It is probable that online and/or over-the-telephone transactions may be the only forms of debit/credit card payment processing depending upon pricing and regulatory constraints.

4. Would the accounts be created by file batch upload? – this is the preferred method

NHES Response: It is believed that creation by file batch upload would be preferred.

5. Expiration preference? 12, 24, 48 – typical is 12 months

NHES Response: Expiration preference would be 24 months subject to eligibility and circumstances.

6. Is the account personalized?

NHES Response: The card should be personalized to the individual payee.

a. Is standard card art or branded card art a requirement?

NHES Response: No branded card art would be required.

NHES Response: Reloadable cards.

10. Are there any additional administrator participants involved other than the Department of Employment Security?

NHES Response: Additional administrator participants are not anticipated at this time.
